

WAIVER AND RELEASE OF LIABILITY

WITNESS THIS AGREEMENT this ____ day of _____, 20 ____, by and between James Praus and Tonya Praus DBA Crazy 8 Cattle, hereinafter referred to as MANAGER and _____ hereinafter referred to as RIDER, and if RIDER is a minor, RIDER'S parent or guardian, _____. In consideration received, and in return for the use of Manager's animals and equipment, the parties hereby agree as follows:

1. INHERENT RISK AND ASSUMPTION OF RISK: The undersigned acknowledges that there inherent risks associated with bull riding and expressly assumes all risks associated with participating in such activity. The undersigned further acknowledges that participation in and presence at a bull riding event exposes he or she to serious and substantial hazards, risks of property damage, physical injury and/or death, and that he or she has been fully warned with regard to all such risks and hazards. The risks are not restricted to competition, but also include being in the arena, behind the chutes, in the livestock holding area, pens and any other area associated with bull riding events. Rider assumes all risks and warrants a full and complete disclosure of Rider's abilities have been made to Manager.

2. RELEASE OF LIABILITY: Rider and his or her next of kin, heirs, representatives, successors and assigns, unconditionally and irrevocably agree to assume all such hazards and risks and do hereby unconditionally and forever discharge, waive, hold harmless and release, Manager and their subsidiaries, affiliates, officers, directors, shareholders, employees, members, agents, representatives, officials, judges, bullfighters, volunteers and other contractors, together with all other parties or entities involved in the sanctioning, approval, production, organization, conduct, sponsoring, advertising and performance of this event and activities for any matter relating to Rider's participation in any events or relating to this waiver and release (and each such persons' or entities' affiliates, officers directors, employees, volunteers and agents) (collectively "Releasees") from any and all claims, demands, losses, costs, liabilities and responsibilities arising from or in any way relating to Rider's participation in or presence at any and all events by Manager and Releasees including any claims, demands, losses, costs, liabilities, or other responsibilities that are known or unknown, seen or unforeseen, future or contingent, and whether or not such claims, demands, losses, costs, liabilities, or other responsibilities are occasioned, in whole or in part, by the negligence of Manager and/or Releasees, or otherwise. Further, in consideration of being able to participate in this event, Rider hereby indemnifies and shall continue to indemnify and agree to hold harmless Manger and Releasees from any and all claims, liabilities, actions, and costs, asserted, made or threatened by any person (including without limitation, any employer, spouse, parent, child or other next of kin) in respect to all injuries and damage, personal injury or death occasioned by Rider by virtue of or arising out of Rider's participation in the event. Rider will not now or at any time in the future, directly or indirectly, commence, threaten or prosecute any claim, action, suit or other proceeding against Manger and/or Releasees, or any of them, arising out of or related to the claims, demands, liabilities and other responsibilities that Rider assuming, discharging, waiving and releasing by signing this Agreement.

3. MEDICAL AUTHORIZATION: Rider hereby authorizes any medical treatment deemed necessary in the event of any injury while participating in the activity. Rider shall have appropriate insurance or in its absence, agree to pay all costs of medical services that may be incurred on Rider's behalf.

4. MEDIA AUTHORIZATION: Rider agrees to the use of any media (photos and videos) for promotional purposes.

I, the undersigned parent and/or legal guardian, affirm that I am freely signing this agreement. I have read this form and fully understand that by signing this form I am giving up legal rights and/or remedies which may otherwise be available to myself, the minor participant regarding any losses the minor participant may sustain as a result of participation in the activity, and sign freely and voluntarily without any inducement, assurance or guarantee being made to me and intend my signature to be a complete and unconditional release of all liability. I agree that if any portion is held invalid, the remainder will continue in full legal force and effect.
